PROPOSITIONS

PROPOSITION NO. 1

Shall the Northwest Rogers County Fire Protection District be authorized to incur indebtedness for the purposes of maintaining, acquiring, leasing, and purchasing trucks, vehicles, equipment, and property ('Purchases') through loan agreements, revolving lines of credit, lease purchase agreements, or bonds where the annual payments due for such Purchases shall not exceed the total sum of \$500,000?

If this Proposition #1 is approved, the annual payments shall bear or reflect interest; shall be payable from assessments levied as provided by law; shall, under any lease purchase or loan agreement, pay both principal and interest and the term of any bonds, lease purchase or loan agreement shall not extend past April 30, 2028. Over the term of this approval, the total debt that the District could have outstanding at any one time would be capped at a maximum of \$3,000,000 for purchasing trucks, vehicles, equipment, and property subject to the yearly limitation that payments shall not exceed the total sum of \$500,000.

PROPOSITION NO. 2

Shall the Northwest Rogers County Fire Protection District be authorized to incur indebtedness by issuing bonds, promissory notes or other evidences of indebtedness, including lease purchase agreements, in an amount not to exceed \$7,500,000 ('indebtedness') to provide funds for the purpose of a) acquiring, constructing, repairing, improving or leasing new and existing fire station sites, buildings, and equipment and b) paying for miscellaneous engineering, legal and similar costs incident to (i) cost projections (ii) design and engineering work, and (iii) acquisition of funds?

If Proposition 2 is approved, the Indebtedness shall bear interest and be payable solely from assessments levied, as provided by law, in installments for a term not to exceed 25 years and the District will proceed with the improvements in the following order as estimated, to wit:

Station 1 (Oologah)	\$4,500,000
Station 3 (Sageeyah)	\$800,000
Station 2 (Talala)	\$1,700,000
Station 4 (Satellite Station)	\$250,000
Station 5 (Satellite Station)	\$250,000

To reduce costs, the Indebtedness (Station 1) may be expended to relocate to another location in Oologah in combination with other emergency services. Stations 4 and 5 will only be undertaken if operational funds are sufficient. State Law requiring competitive bidding shall be applicable.
