

# OKLAHOMA APPLICATION FOR ABSENTEE BALLOT

If you are **1)** an inactive voter, **2)** have been identified by the National Change of Address as having moved, **3)** have an invalid address for mailing by USPS, **OR 4)** have had a Voter ID card returned as undeliverable, you will need to complete the attached Address Confirmation Form and submit it with your absentee request. You may also request absentee ballots using the secure OK Voter Portal at [oklahoma.gov/elections/ovp.html](https://oklahoma.gov/elections/ovp.html). Contact your County Election Board for information.

IT IS A FELONY TO KNOWINGLY EXECUTE A FALSE OR FRAUDULENT APPLICATION FOR ABSENTEE BALLOTS. 26 O.S. § 16-101 and 102.2.

# OKLAHOMA APPLICATION FOR ABSENTEE BALLOT

## INSTRUCTIONS

All applications must be received by the County Election Board in the county where you are registered to vote by 5 p.m. on the third Monday (15 days) before an election.

Absentee Ballot Applications are valid for up to one calendar year.

Uniformed Services members/spouses/dependents and Overseas Citizens can complete an application at [oklahoma.gov/elections/ovp.html](https://oklahoma.gov/elections/ovp.html) (scan QR code) or [fvap.gov](https://fvap.gov).



Section 1	<ul style="list-style-type: none"><li>• Print your name as you are registered to vote.</li><li>• Print your date of birth (MM/DD/YYYY).</li><li>• State law requires voters to provide an identification number that matches the identification number provided on their voter registration record. You must supply an Oklahoma driver's license number / State ID number or the last four digits of your Social Security number. (<a href="#">26 O.S. 14-105</a>) If you do not know which number you used for your voter registration, please provide both.</li></ul>
Section 2	<ul style="list-style-type: none"><li>• Provide the physical address used for your residence address on your voter registration. Do not provide a rural route or P.O. Box number. If you are an inactive voter, or if you have been identified by the National Change of Address as having moved, or if your address is invalid for mailing by USPS, or if you have had a voter ID card returned to the county election board as undeliverable, you must confirm your voter registration address when submitting this application. (<a href="#">26 O.S. § 14-105</a>) Contact your county election board for more information.</li></ul>
Section 3	<ul style="list-style-type: none"><li>• If you want your ballots mailed to an address other than your voter registration address, check the appropriate box and provide the mailing address where you want your ballots to be mailed.</li></ul>
Section 4	<ul style="list-style-type: none"><li>• If you are physically incapacitated and cannot vote in person due to your physical incapacitation, check the first box. If you choose an agent to deliver your application, the agent must print their name and sign the application in the box provided.</li><li>• If you are charged with the care of a physically incapacitated person who cannot be left unattended, check the second box. If you choose an agent to deliver your application, the agent must print their name and sign the application in the box provided.</li><li>• If you are in a nursing home or veterans center, check the third box and print the name of the facility.</li><li>• If you are requesting a "standard" (no-excuse) absentee ballot, check the fourth box.</li></ul>
Section 5	<ul style="list-style-type: none"><li>• If you want absentee ballots mailed to you for all elections in which you are eligible for this calendar year, check the first box.</li><li>• If you want absentee ballots for a specific election, check the second box and print the date(s) of the election(s) in which you wish to vote by absentee ballot.</li></ul>
Section 6	<ul style="list-style-type: none"><li>• If you are an Independent voter, you may check the box to request an absentee ballot for the Democratic Primary and/or Runoff Primary. <b>NOTE:</b> Only the <b>Democratic Party</b> currently allows Independents to vote in its Primary and Runoff Primary elections.</li></ul>
Section 7	<ul style="list-style-type: none"><li>• Read the oath, then sign and date the application before submitting.</li></ul>

**You must submit your own absentee ballot application.** You may submit it by mail, email, or fax to your County Election Board. You may also hand deliver your application to the County Election Board office. If you do not have an identification number or date of birth on file with your County Election Board, you must submit your application in person, by mail, or by fax. (**EXCEPTION:** A voter confined to a nursing home or veterans center, a physically incapacitated voter, or a voter charged with the care of a physically incapacitated person may choose an agent to deliver the application to the County Election Board or send it by mail.)
